

## Youth Water Forum 2022

### Video Application Rules

All applicants must read the following Application Rules before submitting their application. By applying to this program, the applicant shall be deemed to have read and consented to these rules.

#### 1. General Rules

- 1.1 The applicant is solely responsible for applying to participate in this project.
- 1.2 In the case of a group of authors, there must be unanimous agreement to apply among the members.

#### 2. Permission of Parents

- 2.1 Applications by minors require the consent of their parents.
- 2.2 In the case of a group of authors, all those under 18 years of age are required to obtain the consent of their parents.
- 2.3 All applicants under 18 years of age shall be deemed to have obtained the consent of their parents when submitting an application.

#### 3. Copyrights and Portrait Rights

- 3.1 The applicant reserves all the rights related to the video even after submission.
- 3.2 The applicant agrees to authorize the organizers to use the video free of charge. (Videos will be used mainly for public screening and publicity purposes.)
- 3.3 The applicant must obtain all necessary permissions from any third parties whose work is included in the video before submitting an application, along with permission for the organizers to use the video. If any music, pictures, images, or illustrations produced by authors other than the applicants are included in the video, the applicant is required to obtain all necessary consent and permissions of the copyright owners prior to submission. Should there be a dispute over a video between a third party whose work is included in the video, copyright owners, and the organizers, the applicant must assume sole responsibility for settlement of the dispute. The organizers accept no responsibility for the

outcome of any settlement.

- 3.4 Any personal information the organizers obtain at the time of application will be used only for the purpose of running this program and will not be used for any other purpose.

#### 4. Rejection Criteria

A video will not be accepted if it:

- 4.1 Infringes on copyrights, portrait rights or any other rights of third parties
- 4.2 Disrupts public order
- 4.3 Is not the work of the applicant
- 4.4 Is produced for profit, advertisement, or solicitation
- 4.5 Slanders individuals, companies or organizations, or violates privacy
- 4.6 Impersonates another party (company, organization)
- 4.7 Impedes the normal operations of this program
- 4.8 Is deemed inappropriate by the organizers

#### 5. Important Notes

- 5.1 The organizers may at their sole discretion stop public screening of a video even after it has been publicized, if the applicant fails to follow the application rules, or misconduct and infringement on or violation of the rights of any third parties are found.
- 5.2 The contents of any judgment as to whether a video meets the application requirements will not be disclosed.
- 5.3 The applicant is solely responsible for any and all costs incurred in shooting the video and submitting an application. The organizers do not rent out cameras or editing equipment.
- 5.4 In shooting a video, all those involved must observe rules and good manners under the authority of the director for carrying out the work safely.
- 5.5 The application rules may be subject to change if deemed necessary by the organizers. In such cases, information about the change of rules and revised rules will be posted on our official website or announced in other appropriate ways. In the absence of any separate statement, the date of the publication of revised application rules shall be the date they go into effect.

## 6. Disclaimer

6.1 The organizers assume no responsibility for any loss or damages incurred by the applicant or any third parties resulting from shooting, editing, or submitting a video and its accompanying information. The organizers are also not responsible for any loss or damages arising out of the use of internet services at the time of submission.

6.2 The organizers may change, interrupt, stop or end this program without notice due to unavoidable circumstances. In such a case, the organizers accept no liability for any losses incurred by the applicant or any third parties.
