Please read and agree to the following before submitting your application to this call for proposals. By submitting your application, you are indicating your agreement to these terms and conditions.

## (I) GENERAL CONDITIONS

- · Applicants shall apply at their own risk.
- · If applying as a group, please obtain all necessary consents from each group member.

### (2) RESPONSIBLE PERSON

- The Organizer will not be held responsible for the content of the video.
- · If the entrant is a minor, the person responsible must obtain the consent of a parent or guardian as indicated below before submitting the entry.
- · If the entrant is a school or other group, a teacher must be the responsible person. If the applicant is an individual, the parent or guardian must be the responsible person.
- · If applying as a group, all minors in the group must obtain the consent of their respective parents or guardians before submitting the application.
- The application will be deemed to have been submitted with the consent of all parents or guardians of the minors.

## (3) PORTRAIT RIGHTS, COPYRIGHTS, ETC. WHEN PRODUCING THE VIDEO

- · If a person appears in the submitted video, please obtain the person's permission before submitting the video.
- · If a person is in the submitted video, please obtain permission from that person to submit the video.
- · Please do not film in areas where filming is prohibited.
- If you wish to use text, music, images, illustrations, or videos created by someone other than the members of the production group in your submitted video, please obtain the permission of the copyright holder of the relevant work before submitting it. However, when quoting text, images, illustrations, or videos, please be sure to clearly state the source in the video.

#### (5) UNACCEPTABLE VIDEOS

Entries that meet or may meet any of the following criteria cannot be accepted.

- · Entries that infringe on the copyright, portrait rights or other rights of third parties.
- · Entries that are created using generative AI
- · Entries that are offensive to public order and morals.
- · Entries that have been created by someone other than the entrant.
- · Entries that provide information, advertisements or solicitations for profit.
- · Entries that defame or invade the privacy of individuals, companies or organizations.
- · Those that impersonate other individuals, companies or organizations.
- · Those that damage the reputation or credibility of this video call and damage trust in it.
- · Entries that obstruct the proper operation of this call for videos.
- Entries that contain misinformation, inaccurate expressions or obvious exaggerations in the content of the work.
- · Entries that the Organizer deems inappropriate.
- · Any other entries similar to those listed above.

#### (6) IMPORTANT NOTES

- · If a submitted video is later found to violate these terms or involve fraudulent activity or third-party rights infringement, the Organizer may cancel its publication.
- $\cdot$   $\;$  The Organizer will not disclose details about the screening process.

- · All expenses related to video production and submission shall be borne by the applicant.
- · The Organizer will not lend cameras, editing equipment, or other devices.
- · Please follow local rules and safety protocols when filming.
- · Do not film in prohibited areas.
- These terms may be amended if necessary. Changes will be announced on the Organizer's website or other official channels.

## (7) DISCLAIMER

- The Organizer shall not be liable for any damages incurred by the applicant or third parties due to the filming, production, or submission of the video, or through the use of related internet services.
- The Organizer reserves the right to change, suspend, or terminate the call for videos without prior notice for unavoidable reasons. In such cases, the Organizer shall not be held liable for any resulting damages.

## (8) PERSONAL INFORMATION

• Personal information submitted will only be used to the extent necessary for achieving the objectives of this video application.
